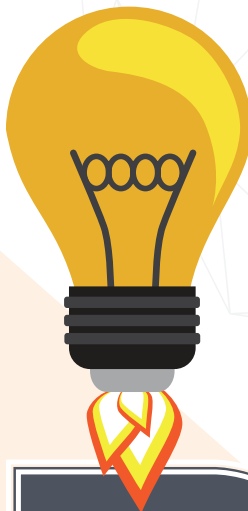
IPrism will provide a unique opportunity for students to learn and showcase their understanding of IPRs.

**Deadline for submission:
31st March, 2018**

Eligibility Criteria



- Entries should be new and innovative.
- Team work is allowed. A team should not have more than 6 members.
- Multidisciplinary and multi-national teams are welcome.
- Multiple teams per college/institute can participate.
- A team is allowed to include one technical or professional person in their team who is not a student / part of an institution.
- All students at various stages of their university careers, full-time or part-time, from undergraduate to postgraduate level (including masters and doctorate) can participate.
- Paper prototypes or non-digital games are not acceptable.
- IP Game should be iOS or Android compatible.
- IPR Film on Piracy and/or Counterfeiting: 30 and 60 seconds short films or animated videos are allowed.
- Participants are free to design their scripts for the IP game. For reference, please have a look at the sample script at www.iprism.co.in.

IP Game:

- Screenshots and a short video of the gameplay.
- Maximum size should not be more than 110 MB.
- Game must function, as single-player game and/or multiplayer game.
- Game should refrain from the use of store-bought or purchased assets and cannot have in-app purchases.
- Game should use only open source technologies.
- App should be compatible with Android “KitKat” and above and iOS 10 and above.
- Please include ‘Help’ section in the app including ‘How to Play’.
- A sample script for an IP Game is provided on the IPrism website. It is not mandatory for the participants to use this script.



IP Film: Piracy and/or Counterfeiting:



- 30 seconds OR 60 seconds animated / film videos.
- Maximum size should not be more than 110 MB. HQ videos required (if shortlisted).
- Participants are requested to retain the HQ or decent quality videos; it may be required after the shortlisting procedure.
- Minimum Pixel (if shortlisted): 1280 X 720 (Normal) or 1920 X 1080 (HD Resolution).
- Standard-definition video version: PAL (Phase Alternating Line).

Selection Criteria

**All indicators will carry equal weight.*



IP Game:

Criteria	Explanation
Documentation	Creative process – How well are the IP concepts explained.
Supporting Material	How well do graphics, images, concept art and scripts support the documentation.
Thematic Consideration	The extent to which the GDD identify the consideration of the competition theme taken throughout the development of the game.
Execution	How effectively the GDD mirror the finished product.
Functionality	Working of the game. Compatibility of the game with every system & crashes or glitches. Bug testing.
Visual Design	User Interface: If the visual style is consistent and appealing.
Gameplay	Game's ludology level. Objectives of the game. Game's mechanics.
Engagement	How fine and engaging the game is.

GDD: Game Design Documents

IP Film: Piracy and/or Counterfeiting:



Criteria	Explanation
Documentation	Creative process – How well are the IP concepts explained.
Supporting Material	How well the graphics, images, concept art and scripts support the documentation.
Narrative flow	The narrative/story telling flow. How strong, original, compelling, and interesting the film is.
Execution	How closely does the film production mirror the finished product.
Visual Composition	How consistently the film shows excellent and creative visual.

Prizes

Prizes for the winners are:

IP Game:

- **First Prize:** INR. 1 Lakh, memento and certificate.
- **Runners-up:** Rs.50,000 each, mementos and certificates. (2 teams)
- Top ten teams/participants will be awarded mementos and certificates.
- All Winners will get a special mention on CIPAM's Website – cipam.gov.in.

IP Film: Piracy and/or Counterfeiting:

- **Winner Award:** Rs. 1 Lakh each for the 2 categories: 30 seconds and 60 seconds film along with memento and certificates.
- Top ten participants will be awarded mementos and certificates.
- All Winners will get a special mention on CIPAM's Website - cipam.gov.in.
